I, the undersigned, am the parent or legal guardian of the above-named Camper. By signing this Activity Release ("Release") I am declaring the following:

1. I consent to Camper participating in one or more of the following activities offered by OVS Summer Camp: camping, backpacking, ropes course program, rock climbing, hiking, mountaineering, canyoneering, roller blading, cycling, swimming, surfing, boogie boarding, skate boarding, cooking, equestrian activities, woodworking, project services and sports. The activity(ies) may take place at an off-campus site or at one of the Ojai Valley School campuses.

I understand that working around and riding horses, ponies, and mules are hazardous activities, and I assume full responsibility for injury to the listed camper while he/she may be participating in any stables activity, to the extent said injury exceeds policy limits of applicable OVS insurance, if any, at the time of injury. **WARNING:** Horseback riding is a hazardous activity. Being in a stable environment can be hazardous. Horses are large, unpredictable animals who can inflict accidental injuries. We ask that if you decide to interact with the animals, please listen to your instructor closely to avoid harm and to get the most out of your camp experience.

2. I fully understand and appreciate the potential dangers, hazards and risks, which include the loss of life, limb or property, directly or indirectly inherent in participating in these activities, including, without limitation, the risks due to the inherent unpredictability of horses.
3. I understand and recognize that Camper and I are responsible for Camper's well-being and the well-being of the other participants. I declare that I recognize that it is in Camper's best interest, as well as that of the other participants, to follow the suggestions, guidelines and/or rules of the activity(ies) supervisor(s) and/or coordinator(s) and that Camper's participation in any activity(ies) is entirely voluntary or is at the direction or request of persons or entities not associated with OVS or is at the direction or request of persons or entities associated and not associated with OVS.
4. I understand that any OVS Summer Camp personnel or agents also participating in any activity(ies) are not necessarily medically trained to care for any physical or medical problems that occur during any activity(ies). I further understand that OVS does not carry liability insurance for me or Camper while Camper is participating in any activity(ies). By placing my signature below, I acknowledge to OVS that I have adequate medical and hospitalization insurance for any injuries that may result from Camper's participation in any activity(ies).
5. In consideration for Camper being allowed to participate in any activity(ies), I agree to hold harmless the supervisor(s) and coordinators(s) of the activity(ies), OVS, its Board of Trustees, agents, officers and employees for any and all direct, indirect, special or consequential damages, or costs, legal and otherwise, which I or Camper may incur as a result of Camper's participation in any activity(ies), even if due to the active or passive negligence of OVS or any person serving in the above-identified capacities.
6. As the parent/guardian of Camper, I have read and understand the terms and conditions of this Release, and I voluntarily agree to the terms and conditions stated herein. I warrant that I am authorized to execute this Release on behalf of Camper. This Release shall be binding upon the heirs, administrators, executors and assigns of the undersigned. I further agree to indemnify, defend and hold harmless OVS, its agents, officers, employees and representatives from any and all actions, claims, demands, loss, costs, expenses, obligations, liabilities, and damages, including incidental and consequential damages, recoveries and deficiencies, including interest, penalties and attorneys' fees, incurred or suffered by OVS relating to or arising out of or in connection with any action brought against OVS by the Camper, whether before or after reaching the age of majority.
