



## SUMMER 2026 LAX TRANSPORTATION INFORMATION

OVS Summer Camp will provide transportation to and from Los Angeles International Airport (LAX) for Campers who have an airline reservation on either one of our starting or ending session dates. The fee for this service is \$200.00 each way.

Parent(s)/Guardian(s) are to be responsible for making reservations and ticket purchases for all transportation arrangements.

Please contact the airlines regarding their unaccompanied minor regulations. The Parent/Guardian must pay any and all fees for unaccompanied minor services at the time of booking. Copies of airline tickets should be sent to our Summer Admission Office at [summer@ovs.org](mailto:summer@ovs.org) THREE WEEKS PRIOR to your camper's session start date.
